Department of Natural Resources & Conservation Timber Sale

The Antice Flats Timber Sale is located within Sections 3,4,10,14,15,23, & 24 of T33N-R23W and Sections 33 & 34, T34N-R23W on the State's Stillwater Unit. Approximately 27,931 tons, consisting of mixed conifer sawlogs, are offered for sale.

Sealed bids will be opened at the Department of Natural Resources & Conservation, 2705 Spurgin Road, Missoula, Montana on **June 24, 2025 at 2:00 p.m.** Bids may be hand delivered or mailed and will be accepted any time prior to the bid opening. DNRC recommends that bidders contact the Trust Land Management Division (406-542-4300) prior to the bid opening to ensure that your bid has been received. **Bids must be accompanied by a deposit of \$19,691.00**, representing 5% of the minimum bid value of the sale in cashier's check, certified check, bank money order or bank draft to be applied to the first sale invoice for the successful bidder. Bid bonds will be accepted and, for the successful bidder, will be closed upon execution of the Timber Sale Contract and Timber Sale Bond.

The sale will be awarded to the highest responsible bidder. Award of the timber sale is conditional upon approval of the timber sale by the State Board of Land Commissioners at their June 16, 2025, meeting. If the successful bidder is unable to execute the contract within **30** calendar days from the date the sale is awarded, the bid deposit will be retained by the Department as liquidated damages. The right is reserved to reject any or all bids.

General Bidding Information

- 1. Bids must be submitted on Department of Natural Resources & Conservation (State) bid forms.
- Timber will be sold to the highest responsible bidder; however, the State reserves the right to reject any or all bids.
- 3. The State recommends that bidders contact the Forest Management Bureau, Trust Land Management Division (406-542-4300) prior to the bid opening to ensure that your bid has been received.
- 4. A **Bid Deposit** must accompany all bids and must be in the form of cash, cashiers check, certified check, money order, bank draft, surety bond or irrevocable letter of credit.
- 5. The Purchaser must submit a **Performance Bond** to the State within 30 days of notification of sale award. The bond amount will be, at a minimum, 20% of the total bid value of the sale. The performance bond may be cash, irrevocable letter of credit, surety bond or certificate of deposit. The performance bond must be maintained separately from other payments for the duration of the Timber Sale Contract. See the Timber Sale Contract for additional information.
- 6. The purchaser must submit an **Advance Stumpage Payment** prior to cutting any timber. The amount of the advance stumpage payment will cover six weeks of harvesting and be based on the expected harvest rate and the bid value of the stumpage. The advance stumpage payment may be cash, irrevocable letter of credit, payment bond or certificate of deposit.
- 7. At rates specified in the Contract, the purchaser will pay **Forest Improvement Fees** on all sawlog volume. All applicable **Road Use and/or Maintenance fees** will also be paid by the Purchaser in addition to stumpage payments.
- 8. This sale is being sold based on the gross weight of all species. Minimum price and bid price are on a per ton basis. Unless otherwise specified, the price applies to all species, green and dead. Price may vary by product. Billing will be based on gross weight. A weight ticket from a certified scale is required for each load hauled, regardless of product type.
- 9. The State has estimated the net scale merchantable sawlog volume to be sold under this Contract. Other products may be part of this sale. All delivered wood will be weighed and billed at per ton bid rates. The State recognizes that a percentage of delivered wood may not meet the log manufacturing and recovery standards of the Timber Sale Contract. The actual percentage will vary based on the log manufacturing and recovery specifications of the purchaser and tree conditions in the sale area. The actual delivered weight may vary, resulting in an overrun or under-run of the estimated tonnage. The State strongly recommends that bidders evaluate these effects before bidding.
- 10. The State does not conduct detailed road appraisals. All appraised costs are gross estimates or averages, provided only to show the relative amount of work required, and not the true market value. <u>The State strongly recommends that bidders make their own estimates based on Contract requirements</u>. Cost estimates provided are not guaranteed.
- 11. Bidders are encouraged to examine the complete Timber Sale Package and Sale Area prior to bidding. Additional information is available at the phone numbers shown above.
- 12. Estimates for sale volume, species percents, defect, product class, etc. provided in this prospectus and volume estimates listed in the Timber Sale Contract <u>are not guaranteed.</u>
- 13. <u>This prospectus is provided for information purposes only.</u> If the prospectus is in error or contradicts the Timber Sale Contract, the Contract governs.

- Access: Hwy 93N to Upper Whitefish Road. Units will be accessed from the Upper Whitefish Road, the Stryker Ridge Road, and the Antice Loop Road (see attached maps for unit specifics).
- Roadwork: (see Attachment B for roadwork specifics).
 - 26.3 miles of road maintenance and brushing.
 - 1 CLT installation and removal to access part of Unit 12.
 - Drain-dip and water-bar installation requiring gravel, talus, and pit run hauled from the Chicken Pit near the 7-mile marker and junction with the Lower Whitefish Road.
 - o "Stillwater Blend" grass-seed required on designated roads post-harvest.
 - Dust abatement required at the junction of Upper Whitefish Road and Hwy 93N and at the 9-mile junction of the Upper Whitefish Road.
- Harvest Details: Approximately 3.86 MMBF will be harvested from the Antice Flats Timber Sale. (see attached contract for harvest unit specifics).
 - o Units 1 and 2 are clear-cuts that comprise 306 acres and approximately 2.432 MMBF of the sales volume.
 - Units 3 through 13 are commercial thins that comprise 332 acres and approximately 1.428 MMBF of the sales volume.
- Open Road Hazard Reduction: A total of 76 acres will require open-road hazard reduction. This requires 100 feet inside the identified portion of the cutting unit boundary to be mechanically piled in which 90% of the slash generated through logging and small tree slashing be machine piled for burning (minimum pile size of 6 feet) as directed by the Forest Officer.
- Winter Recreation: There are multiple Winter Recreation Land Use Licenses held within the sale area. Extra coordination and mitigations will be required for harvesting and hauling in winter months. The extra coordination during the winter includes the following:
 - Log hauling must be conducted during the normal work week (Monday Friday). Exceptions to this may be considered on a case-by-case basis by the Forest Officer.
 - Log hauling will not be conducted on holidays.
 - Communicate timelines, schedules, and changes with the Forest Officer allowing for time to make appropriate changes.
 - Snow plowing operations will leave 1 2 inches of snowpack on the haul route to accommodate snowmobile traffic.
 - o Feather edges of plowed snow berms for cross traffic on haul route.
 - o Communicate directly with recreation licensees to deconflict traffic.
 - Forest officer will post recreation-related traffic signs.




Antice Flats Timber Sale Map (Units 1, 2 & 13)







Antice Flats Timber Sale Map (Units 3-7,11 & 12)






Antice Flats Timber Sale Map (Units 8, 9 & 10)








Antice Flats Timber Sale Road Map
