- Data integrity in the e-ISuite database is important. Ensuring all fields are completed accurately remain a
  priority to Agencies within the Northern Rockies Geographic Area.
- 7 All Complex IMT incidents within the Northern Rockies will complete the Payment Agency field in the e-
- 8 ISuite COST module. Type 3 IMT's are encouraged to complete the Payment Agency field if they have the
- 9 capacity to do so.
- 10 All IMT's for all Northern Rockies fires having a Cost Share Agreement will complete the Payment
- 11 Agency field.

(1) The Payment Agency for each Aircraft (A#) may be different depending on which Agency owns or has the aircraft on contract. This could be any of the federal agencies (usually USFS or BLM) or the States (MT or ID). Air Operations can provide this information to the Cost Unit Leader.

\* Note: <u>Code individual agencies for all federal agencies (i.e. BLM, USFS, BIA, etc.) do NOT use FED.</u> The only exception to this is costs that are too difficult to break up by agency. For example- the BUYT spreadsheet or Mobilization/Demobilization may use FED.
