This cost share agreement is between the agencies identified above, as negotiated for the following incident in accordance with the Statewide Cooperative Fire Protection Agreement #L17-FMA00001 executed between the parties on August 1, 2017. Other conditions relative to this agreement:

- 1. Costs incurred by cooperators not engaged with the host agency or IMT in the fire suppression activities will not be included as a part of this cost share agreement.
- 2. Responsibility for tort claim costs will not be a part of this agreement. Responsibility for these costs will be determined outside this agreement.
- 3. Costs for accountable, sensitive, and durable property purchased by each agency will be charged directly to that agency and will not be shared.
- 4. Non-suppression rehabilitation costs are the responsibility of the jurisdictional agency and will not be shared.
- 5. Each agency will bill for their costs as outlined in the Statewide Cooperative Fire Agreement billing procedures.



Cost Share Methodology:

The percentage of acres burned methodology was chosen for this fire because it is the most fair and equitable based on the values at risk. Costs will be calculated using e-Isuite estimates initially, but final cost will be divided using actual reporting costs provided by each agency at a later date. The 2% "other" accounts for the wetland area, these acres may be added to the FWS total acres. See the attached map for incident acreage and for the final IMT e-ISuite estimated costs.
