Protecting Agencies' Strategies

On 09/11/2024 at 1357 hours. Suppression actions were immediately taken by Campbell County Fire Department and Powder River County, Montana resources. Weather, fuels, and terrain were conducive to active fire spread. Due to significant fire spread, hazards (terrain, county roads) initial response assessed values at risk, provided immediate point protection and evaluated natural and manmade barriers for suppression actions.

Cost Share Methodology and Rationale:

It is agreed upon, that the cost basis on the Short Draw Fire is as follows and effective as of September 11, 2024, at 1357 hours, no mutual aid period will apply. The percentage of acres burned methodology has been chosen for this incident because of the values at risk and the effort was equal for all agencies involved. See current attached map for incident acreage dated 09/20/2024 and a final version will be provided at end of incident.

All costs associated with the suppression of the Short Draw Fire will be shared between the Bureau of Land Management, Montana Department of Natural Resource and Conservation, Campbell County Fire Department based on jurisdictional/protection boundaries percentage of the acres burned during this cost share period. The Montana Department of Natural Resources and Conservation will assume responsibility for not only State but affected private lands in Powder River County, MT. The percentage split on a per acre basis will be determined at the end of this cost share period.

Each entity will pay for their own costs and set up a time and place for a final cost share meeting by spring of 2025. At that time, actual total cost of the fire will be determined and used to determine each entity's actual payment cost. Any costs incurred after the final cost share meeting will be the responsibility of the entity that receives the bill.

Repair costs with the exception of those fire line activities that are part of the suppression activities will be the responsibility of the jurisdictional entity.

Cost Share Period:

This agreement becomes effective on the date indicated below and will remain in effect until amended, terminated or end of incident.

Other conditions relative to this agreement:

- 1. This cost share will terminate at a date and time agreed upon by all agency administrators at the conclusion of the incident or when conditions significantly change resulting in a need to end or modify this agreement.
- 2. All costs originating from orders placed by and for the incident that can be reasonably obtained and estimated for the cost share period will be included in this agreement and will be shared based on the Agency Administrators (AA) or Agency Representatives (AR) mutual agreement.

- 3. Agency specific costs will not be shared.
- 4. Responsibility for tort claim costs or compensation for injury costs will not be a part of this agreement. Costs for nonexpendable property purchases by each agency will be charged directly to that agency and will not be shared.
- 5. Costs for accountable, sensitive, and durable property purchased by each agency will be charged directly to that agency and will not be shared.
- 6. Costs incurred by cooperators not engaged in joint fire suppression activities will not be included as a part of this cost share agreement. Responsibility for these costs will be determined outside of this agreement.
- 7. Non-suppression repair costs are the responsibility of the jurisdictional agency and will not be shared.
- 8. Each agency will be responsible for collecting actual cost/expenditure data that will make up their respectable costs.
- 9. The parties to this agreement will meet to determine the total costs of each agency on the incident.
- 10. Each agency (including supporting agencies) will bill for their costs as outlined in the billing procedures of the Wyoming and Master Cooperative Fire Management and Stafford Act Response Agreement (2021-2026) and Montana Master Cooperative Wildland Fire Management and Stafford Act Response Agreement (2023-2027).
- 11. This cost share will terminate when the fire is declared 100% contained and controlled. Costs incurred after the termination of this cost share will be the responsibility of the jurisdictional/protection agency.
